Note :- (4) Candidates included in the Short List should present and produce in person with the original documents for PHYSICAL MEASUREMENT and One Time Verification. **Date,time and Venue of PHYSICAL MEASUREMENT and OTR Verification will be published shortly through SMS and Profile message.**

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates claiming Community/ EWS benefit included in the Short List are required to produceCommunity Certificate / Non creamy Layer certificate/EWS certificate issued by the Revenue authority at the time of OTR Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on **17-05-2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No Candidates scripts are found invalidated as per Notification No :ER XVI (3) 3634/23/EW Dt.19.09.2023.
