Candidates belonging to other reservation groups should produce Non-creamy layer certificate and those who claimed EWS should produce relevant certificate issued by Revenue authority at the time of OTR Verification.

But printout of answer sheets will be issued to those candidates who apply for it by remitting the prescribed fee after the publication of Ranked List. Detailed instruction will be furnished in the Ranked List to be published for the post.
