Note :- (6) Candidates included in the Short List are required to produce Community Certificate/NCLC/EWS Certificate issued by the Revenue authority at the time of OTR Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on **12-06-2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No candidates are invalidated as per Notification No : ER11(2)4009/2023/EW dated 01-11-2023.
