Note :- (5) For online examination, rechecking and revaluation are not allowed but printout of answer sheets will be issued to those candidates who apply for it by remitting prescribed fee after the publication of Ranked List .Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates included in the Short List , eligible for reservation are required to produce Non Creamy Layer Certificate /Community Certificate issued by the Revenue authority.Differently abled candidate should produce Medical Certificate at the time of OTR verification.Economically Weaker Sections are required to produce EWS certificate in the prescribed format for OTR verification.
