Note :- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification and interview. Date,time and Venue of OTR Verification and interview will be published in profile through Profile Message and SMS .

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates belonging to Other Backward Classes included in the Short List are required to produce NonCreamy Layer Certificate as per G.O.(P) No.81/2009/SCSTDD dated 26.09.2009, SC/ST candidates are required to produce Community Certificate in Form III or digitally signed by the Revenue Authority not below the rank of Tahsildar and Candidates belonging to Economically Weaker Section(EWS) as per GO (MS)No.2/2020/P&ARDdated.12.02.2020 are required to produce certificate issued by the competent Revenue Authorities at the time of OTR verification and interview

Note :- (7) Copy of answer scripts of the OMR Test held on **09-06-2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
