Note:- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) SC/ST Candidates included in the Probability List are required to produce Community Certificate (In form III / Digitally signed ) issued by the Tahasildar and Candidates belonging to Other Backward Classes should produce Non Creamy Layer Certificate issued by Village Officer. EWS candidates should produce EWS certificate issued by Village Officer, at the time of OTR Verification

Note :- (7) Copy of answer scripts of the OMR Test held on **11-07-2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after publication of the Ranked List. No Register Numbers of candidates are invalidated As per Notification No : ER II(3) 4006/2023/EW Dated 18-11-2023
