Note :- (3) Candidates included in the Short List should present and produce in person the original documents for One Time Verification. **Date,time and Venue of OTR Verification will be published shortly.**

Note :- (4) The Short list is prepared based on the details furnished by the candidate in the application and subsequent claims made will not be entertained at any stage. The register number of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Short list without further notice.

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) SC/ST Candidates included in the Short List are required to produce Community Certificate in Form III /Digitally signed and candidates belonging to other Reservation groups are required to produce Non Creamy Layer certificate as per G.O (P) No.81/2009/SC/STDD dated 26.09.2009 or EWS Certificate, as applicable issued by the Revenue authority and Differently abled candidates are required to produce disability certificate concerned at the time of OTR verification.

Note :- (7) Copy of answer scripts of the OMR Test held on **07-06-2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No Answer Script is invalidated as per Notification No.ERXIV(1)3609/2023/EW dated 25.10.2023.
