Note :- (3) Candidates included in the Short List should present and produce in person the original documents for One Time Verification. **Date,time and Venue of OTR Verification and Interview will be published shortly.** SC/ST candidates should produce Community Certificate and others Non Creamy Layer Certificate at the time of One Time Verification.

Note :- (4) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (5) Copy of answer scripts of the OMR Test held on 09.11.2023 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No :ERVII (3) 01/2024/KPSC dated 23.02.2024.
