The following is the list of candidates for selection to the post of **L D Typist/Clerk Typist/Typist Clerk(Ex-Servicemen Only)1st NCA LC/AI on Rs.19000-43600/-(PR)** in the **NCC/SAINIK WELFARE Department in KOTTAYAM District**, found suitable by the Commission and arranged in the order of merit based on the Common Main OMR Test held on **12/08/2023**. This Ranked List is brought into force with effect from 20.04.2024 and will remain in force until the candidates are advised and appointed against the NCA vacancies arose due to the paucity of candidates belonging to LC/AI community during the currency of the Parent Ranked List published on 23/02/2021(Cat No:282/2018)

NOTE (1) :- According to the existing procedure, revaluation of Answer Script is not allowed. But Answer Scripts will be rechecked if the candidates apply for through their One Time Registration profile from the Commission's official website www.keralapsc.gov.in by remitting the prescribed fee of Rs. 85/- (Rupees Eighty Five only). The fee can be remitted by e-payment through the portal. Applications submitted in any other manner will not be considered. A period of 15 (Fifteen) days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the web site of the Commission.

NOTE (2) :-Candidates who wish to obtain a photocopy of their OMR Answer Sheets (Part A & Part B) relating to this selection shall submit online Application through their One Time Registration profile from the official website of the Commission, www.keralapsc.gov.in by remitting the prescribed Fee of Rs. 335/- (Rupees Three Hundred and Thirty Five only) via e-payment mode available in the portal. A period of 15 (Fifteen) days time to apply for photocopy of OMR sheets will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission. Application submitted in any other manner will not be considered. A copy of answer sheet will be issued only once to a candidate. Copies of OMR sheets invalidated due to any defect will not be issued.

NOTE (3) :- The entries put in column (5) are based on the Communities specified by the candidates in their Application forms and proved by them with necessary documents. The candidates whose Communities have not been correctly noted in the Ranked List as proved by them in their Application should intimate the fact to The District Officer, Kerala Public Service Commission, District Office, Muttambalam P O, Kottayam-686004 within one month from the Date of publication of the Ranked List to get the benefit of Reservation which they are entitled to. In the absence of timely information regarding discrepancies if any, the candidate will be advised as incorporated in the Ranked List.

NOTE (4) :- The candidates who wish to relinquish their claim for advice from the Ranked List shall submit an Application in the format prescribed by the Commission addressed to the District Officer, Kerala Public Service Commission, District Office, Muttambalam P O, Kottayam-686004. The format is available in the official website of the Commission. The request for relinquishment in respect of those who do not submit the Relinquishment Application in the format prescribed by the Commission will not be honoured under any circumstances. The request for relinquishment in the prescribed format should be duly attested by a Gazetted Officer of State/ Central Government with signature, name, designation and office seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the General Conditions. The request for relinquishment, along with the original of notarized affidavit and self attested copy of an ID proof received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalization of the Ranked List. In the case of the requisitions of vacancies received after the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition based on which he/she is to be advised.

NOTE (5) :- Since a common OMR test with common candidates was conducted for the post, the marks awarded to the candidates included in the Ranked List and mark of OMR test relating to all the candidates who appeared for the test will be published only after the publication of all Ranked Lists (including NCA Selection) which will be finalised on the basis of the common test. The result of rechecking of OMR answer script will be intimated in due course, but photocopy of OMR script will be issued only after the publication of the Ranked Lists for all the posts finalised on the basis of the common test.

NOTE (6) :- The A part and B part of OMR scripts will be destroyed after completing 6 months period from the date of finalisation of the last Ranked List to be finalized on the basis of the common OMR Test.

NOTE (7) :- Result of the candidate with Register Number 1017982 is withheld subject to the final orders of the Hon'ble commission regarding acceptability of the qualification possessed by the candidate .
