G. O. (P) No. 118/2010/LBR. Dated, Thiruvananthapuram, 20th October, 2010.

S. R. O. No.1052/2010.—In exercise of the powers conferred by sub-section (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968), the Government of Kerala hereby make the following rules further to amend the Special Rules for the Kerala Insurance Medical Services, 1993 issued under notification in G. O. (P) No. 23/93/P&ARD dated 29th March, 1993 and published as S. R. O. No. 1142/1993 in Part I Section (IV) of the Kerala Gazette No. 28 dated 13th July, 1993, namely:—

RULES

1. *Short title and commencement.*—(1) These rules may be called the Special Rules for the Kerala Insurances Medical Services (Amendment) Rules, 2010.
- (2) They shall come into force at once.

2. *Amendment of the Rules.*—In the Special Rules for the Kerala Insurance Medical Services, 1993,

(1) in rule 2,

(i) under the heading 'Branch II (Homoeopathy)', for the existing entries, the following entries shall be substituted, namely:

"Category 1. Deputy Director of Insurance Medical Services (Homoeo)

Category 2. Insurance Medical Officer (Homoeo) Grade I

Category 3. Insurance Medical Officer (Homoeo) Grade II

Category 4. Assistant Insurance Medical Officer (Homoeo)."

(ii) under the heading Branch III Ayurveda (Indian Systems of Medicine) for the existing entries, the following entries shall be substituted, namely:—

"Category 1. Deputy Director of Insurance Medical Services (Ayurveda)

Category 2. Insurance Medical Officer (Ayurveda) Grade I

Category 3. Insurance Medical Officer (Ayurveda) Grade II

Category 4. Assistant Insurance Medical Officer (Ayurveda)."

(2) in rule 3,—

(i) under the heading 'Branch II (Homoeopathy)', for the existing entries under category and method of appointment in columns (1) and (2), the following entries shall respectively be substituted, namely:—

"1. Deputy Director of Insurance Medical Services (Homoeo)

(i) By promotion from Category 2

(ii) In the absence of eligible persons under item (i), appointment by promotion from Category 3

2. Insurance Medical Officer (Homoeo) Grade I

By promotion from Category 3

3. Insurance Medical Officer (Homoeo) Grade II

By promotion from Category 4

4 Assistant Insurance Medical Officer (Homoeo) ✓

- (i) By direct recruitment ✓
- (ii) By transfer from qualified Pharmacists (Homoeo) in the Insurance Medical Services Department ✓

Note:—(1) Appointment by direct recruitment and appointment by transfer shall be in the ratio 3:1 starting first by direct recruitment. ✓

(2) In the absence of qualified Pharmacists (Homoeo) in the Department, the quota reserved for appointment by transfer will be filled up by direct recruitment. ✓

(ii) under the heading 'Branch III Ayurveda (Indian Systems of Medicine)' for the existing entries in the category and method of appointment in columns (1) and (2), the following entries shall respectively be substituted, namely:—
