THE CENTRAL PLAN SCHEME MONITORING SYSTEM (CPSMS)—PERMISSIVE SANCTION TO USER DEPARTMENTS TO OPEN BANK ACCOUNTS—ORDERS ISSUED.

ORDER

As per G. O. read above, Central Plan Scheme Monitoring System (CPSMS) was introduced in the State with instructions to all the user Departments/ implementing agencies of Government of India Schemes in the State to register and upload beneficiary data on the CPSMS web portal. General guidelines for implementation of CPSMS were also incorporated in the above G. O. In the meeting held by the Principal Secretary, Finance on 28-1-2013 to review the preparedness of implementation of direct benefit transfer through CPSMS in the State, it was observed that user departments need to open scheme-wise bank accounts for bringing the various schemes under the coverage of CPSMS. In the meeting held by the Chief Secretary on 29-1-2013, a decision was taken to the effect that disbursements to beneficiaries under various Central Sector Schemes would be compulsorily through the CPSMS platform only.

2. In view of the above position, Government are pleased to make CPSMS platform compulsory for direct disbursements to beneficiaries under all Central Sector Schemes in the State. Permission is also granted to all user departments to open scheme-wise bank accounts with the respective banks exclusively for CPSMS-based operations. However, new bank accounts need not be opened for schemes for which a bank account is already operational. The accounts opened for this purpose shall be closed as and when the schemes are discontinued.


